City of Monroe Park Facility Cancellation Policy: Any person who has reserved a facility may cancel a reservation by notifying the Monroe Recreation Department no later than three (3) weeks (21 calendar days) prior to the scheduled use, less 10% handling fee. No refund for inclement weather. Refund will be mailed by check within 30 days of the date of cancellation. Failure to provide cancellation notice within the established time period will forfeit the reservation fee. This Cancellation Policy does not apply to tournament facility rentals.
